



LIABILITY RELEASE AND HOLD HARMLESS AGREEMENT

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING THIS AGREEMENT YOU GIVE UP CERTAIN LEGAL RIGHTS.

I fully recognize that the Explorers Taos event and/or trip that I am participating in by arrangement of the Museum of New Mexico Foundation, its employees, agents, associates, and/or its independent contractors involves inherent risks and dangers, including, but not limited to: hazards of travel by bus, automobile, train, plane, tramway, boat, animal or other mode of transportation which may not be operated nor maintained to standards common in Canada or the United States; forces of nature (including but not limited to extreme weather conditions, storms, avalanches and rock slides); civil unrest; terrorism; illness (including but not limited to altitude sickness and hypothermia) or accidents without access to means of evacuation or availability of medical supplies; physical exertion for which I am unprepared; and damage to or loss of my personal property. I am aware that medical services or facilities may not be readily available or accessible during some or all of the time that I am participating in the event and/or trip.

I am voluntarily participating in this event and/or trip with knowledge of the hazards and risks involved. There are no health related reasons or problems that would restrict my participation in this event and/or trip.

In consideration of being permitted to participate in this event and/or trip and in return for the services provided by the Museum of New Mexico Foundation, its employees, agents and associates, I hereby assume all risks and responsibilities in any way associated with this event and/or trip, and I release the Museum of New Mexico Foundation, its employees, agents and associates, and the Board of Directors of the Museum of New Mexico Foundation (hereafter, the "Releasees") and hold them harmless from any and all liability, claims and actions that may rise from injury or harm to me, from my death or from damage to or loss of my property in connection with this event and/or trip whether caused by the negligence (but not willful or fraudulent conduct) of the Releasees or otherwise.

The terms of this release shall bind my family members, heirs, executors, administrators, assigns or other successors in interest, as well as myself. If any term or provision of this release is held illegal, the validity of the remaining portions shall not be affected. This release will be governed by the laws of the State of New Mexico.
